
3. Schools to give admissions to nearest areas weak class children and grieved class children with prior primary class till 25% figure in Std. 1 and to give free and compulsory Primary Education till the Completion.
4. It is prohibited for to take fee per head and therefore Trust, Mandal or School do not take condition fee or any way order donation or any things instead of fees.

5. For entrance in school do not take any screening test or proceedings of child or he or her Mother - Brother or Guardian.
6. School do not have to abstract for admission to children if lack of evidence or religion, race, cast or any class, birth place or out of them.
7. School should decide that:-

- (1) Admitted any children till the completion the beginning education do not detain or draw out from the school.
- (2) Any children do not deserve physically or mental hares.
- (3) Do not order to any children to pass any board examination till completion of the beginning education of any children.
- (4) Under Rule - 30 every children completed beginning education to give certificate per decided.
- (5) As per provisions of the Act to give admission include / weak class or special necessities students.
- (6) (K) Recruited teachers who are as per National council of teachers and the Government or Section -23 of Sub- Clause (1) authorized Officer decided minimum qualified completed.

(Gh) After published Education Department Date : 27<sup>th</sup> April 2012 Government resolution number PRI - 1110 - 223 - K recruit new teacher for related group necessary to pass decided teachers Eligibility Test. (TET)

- (7) Decided in list of Act Student Teacher ratio or as association in school if classes less than 300 Sq. Ft. from Rule 13 Sub- Rule (1) khand (Gh) decided ratio both of them school performed teachers recruitment do as per decide in list.
  - (8) State Government's rules are effect to pay suitable salary and allowances to teachers and performed their service and conditions.
  - (9) Teacher perform his duty as per show in section - 24 Sub Rule (1) of Act.
  - (10) Male teacher or Female teacher do not join own with Private Education.
  - (11) Transperenent and impartial admission proceedings perform the Central Government and State Government or as commissioner issues directions and orders.
  - (12) The Government or Primary Education Commissioner time to time issued any better order, instructions, directions should performed when recover fee from the students.
8. School to give education as per Superior Mandal made syllabus as per prescribed numbers.
9. As per decided in Act Section - 19 school to give entrance as per receiving facility in the school.




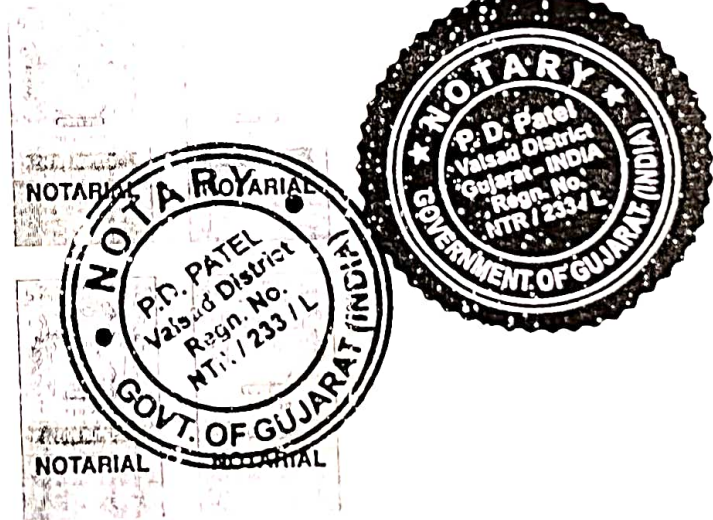
